| <u>Callable Family or Single Golf Membership</u> | \$1,500 | \$6,725.25 | \$4,667.25 |
| <ul style="list-style-type: none"> • Non-refundable initiation fee • Requires a 3 year commitment to being a member • Callable memberships can be “called in” by the Club once the Club reaches full capacity. This means the Club can contact you and ask that you pay the then current initiation fee or the Club can release your membership to another party. • Full privileges in all Club amenities | | | |
| <u>Corporate Golf Membership</u> | \$20,000 | \$6,410.25 | \$4,446.75 |
| <ul style="list-style-type: none"> • Corporate Golf Memberships require a one-time initiation fee and an annual dues obligation for each named designee. Corporate Memberships require at least 2 but no more than 5 designees. • After 100% of initiation fee has been paid, the initiation fee is 80% refundable upon cancellation and reissuance of the membership • Designees can elect to be a Single or Family Golf Member depending on their needs, dues for these memberships are as outlined above. • Full privileges in all Club amenities | | | |
| <u>Young Executive Golf Membership</u> | \$12,500 | \$6,410.25 | \$4,446.75 |
| <ul style="list-style-type: none"> • Available to applicants under the age of 45. • Pay 50% of initiation fee when joining. The remaining 50% is due within 90 days of the members’ 45th birthday. • Non-refundable Initiation Fee • Full privileges in all Club amenities pursuant to membership type (Family vs Single) | | | |
| <u>Social Membership (non-golf)</u> | \$2,500 | \$1,842.50 | \$1,254 |
| <ul style="list-style-type: none"> • Full privileges in all Club amenities, except for Golf. Social members receive no discounts for playing golf. • 50% refundable initiation fee upon cancellation and reissuance of the membership • Social Memberships are currently SOLD OUT; wait list in effect | | | |
